一、 本校公開徵求校長候選人,新任校長任期三年自 114 年 1 月 1 日起至 116 年 12 月 31 日止或 114 年 2 月 1 日起至 117 年 1 月 31 日止。

Christ's College Taipei is openly inviting nominations and applications for the position of President. The President shall serve 3 years from January 1, 2025, to December 31, 2027 or February 1, 2025, to Jan 31, 2028.

 A faithful disciple of Jesus Christ who has professed faith in Christ as the only true Savior and Lord.
- (二) 效忠於本校辦校使命與願景,致力於學生靈命與學識、以及基督教博雅教育之發展。

A person who is committed to the vision and mission of Christ's College Taipei which includes both the spiritual and intellectual development of students and a commitment to the Philosophy of Christian Liberal Arts Education.

(三) 具備公認之學術成就。

A person with recognized academic credentials and achievements.

- (四) 具備良好的領導能力與人際溝通技巧。
 - A person with excellent leadership ability and interpersonal skills.
- (五) 具有發展學校之願景,並激發全體教職員生懷抱願景。

A person with a personal vision for the development of Christ's College Taipei and the ability to inspire the faculty, staff and students to embrace that vision. (六) 具備連結及強化與教會及外界關係之能力。

A person who is able to build and strengthen the relationship of Christ's College Taipei with churches and society

(七) 能夠處理當地及國際事務暨領導中英文雙語學校之能力。

A person who is able to work in a bilingual (Chinese and English) institution with local and international networks.

(八) 具備開發與管理財務及人力資源之能力。

A person who can recruit and manage financial and human resources.

- (五)個人信仰見證(含對本校立校信念與使命之認同)
- (六)三封推薦信函(推薦者包括所屬教會牧師、前任主管、以及其他)。

All candidates shall submit the following documents for the President Selection Committee's review:

- 1. Personal information form, including statement of commitment;
- 2. List of publications, works or inventions;
- 3. Academic contributions, awards and honors;
- 4. A statement of school management philosophy, including (1) leadership style, (2) perspectives on Christian Liberal Arts Education, and (3) integration of faith and higher education learning. (This can be submitted after becoming a candidate)
- 5. Personal testimony and affirmation of foundational statements of Christ's College Taipei.
- 6. Three letters of recommendation from your church pastor, former employer, and one

other.
